Zona de media montaña en el límite con el área costera con arroyos de fuerte pendiente y vegetación singular en sus orillas. Pastizales con ganaderías extensiva mezclados con brezales húmedos. Bosquetes mixtos de robles y hayas.

### 4.2 Quality and importance

El lugar es seleccionado por su importancia para el taxón endémico Soldanella villosa, que ocupa el área más próxima a la ribera de los arroyos de la sierra. La gestión deberá tener en cuenta este criterio de selección limitando el máximo nivel de protección a los 25 metros en cada orilla de esos arroyos. El resto de la sierra alberga una representación interesante de brezales húmedos cuya conservación es muy dependiente del mantenimiento de una adecuada carga ganadera.
